Committee Updates

Academic Affairs (P. Jensen): Triton has been awarded \$1000000 for Workforce Equity Initiative Grant by the Illinois Community College Board. Time frame for the grant is September 18, 2019 to September 17, 2020. The purpose of this grant is to recruit, train and employee 160 individuals in high-need communities within our district. In order to increase workforce skills and boost the economies of African American populations who are underrepresented in skills gap fields 60% (96) of the individuals served must be African American. Triton will be allowed to use the Grant for tuition, equipment, books, support services, and more.

Student Affairs Rep (TBD): As the new Dean positions are filled, a new permanent Student Affairs representative will be selected.

Business and Facilities (G. Abezetian): N/A

Human Resources (J. Klinger): They have a final draft of the updated performance standards that they will be presenting to the executive team for review. They will review the proposed changes and make sure they align with the new Mission Vision statements.

Koslow Martin): Moore About Triton College, was sent out September 20th, with updates about Diversity and inclusion initiatives, confirming that we will be working with external consultants. Diversity Committee will meet with Derrell Carter, our AVP of Communication & Institutional Advancement, as he will serve as the Cabinet liaison for equity and inclusion. The committee will set their first meeting date after priorities are established.

changing to Guided Pathways position in place of Strategic Enrollment Management position.
