A. ACTION EXHIBITS:

i. GM Vehicle Donations

ii. Automotive Technology Vehicle Donations

VP Campos stated this Agreement allows the College's Automotive Department to donate four older Toyota vehicles to Proviso East to make room for newer vehicles.

iii. Agreement with EyeCare Services Partners

VP Campos reported this new Agreement will enable students in the College's Ophthalmic Technician program to participate in clinical education experiences at EyeCare Services Partners facilities.

iv. Agreement with Plymouth Place Senior Living

VP Campos stated this renewal Agreement will enable students in the College's Nursing Assistant and Associate Degree Nursing programs to

participate in clinical education experiences at Plymouth Place Senior Living in LaGrange.

v. College Curriculum Recommendations

VP Campos reported the Nuclear Medicine Technology program will be withdrawn. The Accreditation requires the coordinator of this program to have a master's degree, and it is difficult to find someone with this degree in this field. The radioactivity and equipment will be removed from the H Building. This space will be used for other programs.

vi. Additional Statement of Work with Persistence Plus

Hilary Meyer reported this Agreement with Persistence Plus allows for an expansion of TRUDY, the text nudging program, to all students. TRUDY is AI driven and provides timely updates and support for students. Students have an option to opt out when they enroll at Triton College. Hilary Meyer mentioned the texting program has made a huge impact on students' success because students rely on and develop a relationship with TRUDY. The total cost is funded by the Governors Emergency Education Relief Fund (GEER).

vii. Titles for Library Removal/Weeding

VP Koslow Martin reported this annual action exhibit allows for the removal of outdated titles. These titles will be donated to local libraries to make room for newer resources.

viii. <u>Disposal of Obsolete Telecourse VHS Tapes, Audio Cassettes, & DVDS</u>

VP Koslow Martin stated this action exhibit allows for the disposal of obsolete ETRC Telecourse titles that are considered outdated and no longer effective in circulation.

ix. CampusLogic Agreement

VP Koslow Martin reported CampusLogic offers a cloud-based service that allows higher education institutions to convert paper-based financial aid application processes to automated processes. This quickens the financial aid processes and enables more students to receive financial aid. This Agreement is completely funded by the Higher Education Emergency Relief Fund (HEERF).

x. Agreement with Rosemont Theater

VP Koslow Martin stated this rental Agreement allows Triton College use of the Rosemont Theatre for the College's annual commencement ceremony on May 14, 2022.
